CANCELLATION POLICY. Either party may cancel this contract without cause at any time prior to the event by paying to the other party liquidated damages (agreed not to constitute a penalty) based on the following: One hundred eighty (180) days or more from event date then 25% of deposit, one hundred seventy nine (179) days to thirty one (31) days from event date then 50% of deposit, thirty (30) days or less from event date then 100% of the deposit.

PERMITS, LICENSES & TAXES. All state and local taxes or charges that may be imposed or be applicable to this contract and to the service rendered by 116 are in addition to the prices herein agreed upon, and the Client agrees to pay them. In the event that the Customer's function requires a permit or license from any governing body, local, state or federal, the Customer is solely responsible for obtaining such license or permit at Customer's expense.

CONTINGENCY. Performance of this contract is contingent and conditioned upon Client's performance of its promises, and the ability of 116 to complete same, which 116's performance is subject to available labor, disputes, strikes, or picketing, accidents, government (federal, state, local) requisitions, restrictions upon travel, transportation, food, beverage or supplies and other causes, whether enumerated herein or not, which are beyond the control of 116. In no event shall 116 be liable for loss of profits or other similar or dissimilar collateral or consequential damages, whether based on breach of contract, tort, warranty or otherwise. In no event shall 116's liability be in excess of the total amount of the Client's deposit.

PAYMENT. Payment shall be made by check payable to "116 Farmstead Market & Table." The non-refundable deposit is due upon signing this contract. Final payment is due after completion of service/event and will be invoiced to Client including any taxes, costs, and fees.

LIABILITY. Client agrees to be responsible for any damage done to the employees and equipment of 116 by the Client, their guests, invitees, employees, independent contractors, or other agents under the Client's control.

ACCESS, PARKING. Client shall ensure 116 adequate access and parking so as for a reasonable delivery and service for event. In the event reasonable access and parking is not provided, Client agrees to bear the cost of any additional labor, goods, or services incurred by 116.

DISPUTES. Any dispute relating to or arising under this contract shall be first discussed among the parties in an attempt to find a reasonable resolution of the conflict. In the event the parties are unable to resolve the conflict among themselves, either may seek all remedies available under the law, such claims shall be brought within Oklahoma County District Court, the prevailing party therein to be awarded their costs and attorney's fees.
